### Meeting Minutes

Secretary – Janice mentioned to start to think about who will be Secretary next year, since nominations are in November.

President – Tom reminded the Chapter that nominations are going to happen in November with elections in December.

**C. Misc**

Scott motioned for everyone to get credit for the August meeting since all of the rides were rained out. It was seconded by Traci L. and the group agreed.

Scott A. will be the contact for the Vermont ride next year. It will be earlier this year – August 3<sup>rd</sup>-6<sup>th</sup>, 2012. If you are interested, tell Scott and then Scott will inform you which B&B you are being assigned to. Each person will then call the B&B to book their reservation. Scott mentioned that all the B&B's were very accommodating during the storms that were experienced this year while they were there.

Don questioned who can cancel a ride and if one person can cancel it. Tom stated that the Road Captain is in charge of the ride and can cancel it.
